AN ACT

TO AMEND THE CUSTOMS TARIFF ACT 1986 IN
RESPECT OF CERTAIN ESSENTIAL FOOD ITEMS

[1st January 2000]

ENACTED by the Parliament of the Fiji Islands—

Short title and commencement

1.—(1) This Act may be cited as the Customs Tariff (Essential Food Items Amendment) Act 1999.

(2) This Act comes into force on 1st January 2000.
