**SHIPPING REGULATIONS****SHIPPING (AMENDMENT) REGULATIONS 1996**

IN exercise of the powers conferred by section 28 of the Shipping Act (Cap. 98), the Minister hereby makes the following Regulations -

1. These Regulations may be cited as the Shipping (Amendment) Regulations 1996.
2. The Shipping Regulations are hereby amended by deleting Schedule I thereof and substituting therefor the following -
