HONIARA CITY ACT 1999

(No. 2 of 1999)

The Honiara City Council Appropriation Ordinance 2022

ENACTED By the Honiara City Council with the Assent of the Minister as follows:

1. This Ordinance may be cited as the Honiara City Council Appropriation Ordinance 2022 and shall come into effect on the date it is assented to the Minister of Home Affairs in accordance with section 35 (2) of the *Honiara City Act 1999*.
2. The issue of the sum of Fifty Seven Million Four Hundred Eighty Five Thousand Forty Two Dollars and Thirty Five Cents to the services of the financial year ending 31 December 2022.
3. The sum specified in the preceding section shall be appropriated for the supply of heads and subheads specified in the schedule and in amounts respectively in relation herein.

In exercise of powers conferred by section 21, 23, 34 and section 35 of the Honiara City Act 1999 (Act No. 2 of 1999), the Honiara City Council Makes the Following law:

1 Citation

This Ordinance may be cited as the Honiara City Council (Fees, Rates and

Charges) Ordinance 2022,

2 Commencement

This Ordinance commences 1 January 2022,

3 Schedule 1

The rates and charges specified in Schedule 1, in column 3 of the Table, are the fees, rates and charges imposed by the City Council in 2022 for the services, facilities and permits specified in column 2 in the same row.

4 Schedule 2

The fees specified in Schedule 2, in column 3 of the Table, are the fees charged by the City Council in 2022 for the business licence specified in column 2 in the same row.

In Schedule 2:

“(FO)” means foreign owned;

“(LO)” means locally owned;

The fees set out in Schedule 2 under the column entitled “2022 Fee” are the fees for 2022.
