(LN 43 of 1978)

#### **ASSIGNMENT OF RESPONSIBILITY TO THE DEPUTY PRIME MINISTER**

IN exercise of the powers conferred by section 37 of the Constitution, and acting in accordance with the advice of the Prime Minister, I, HON. PATTESON OTI, Acting Governor-General, assign to the person holding the office of:

#### **DEPUTY PRIME MINISTER**

responsibility for the administration of the Office of the Prime Minister and Cabinet and the conduct of the business of the Government of Solomon Islands specified in the Schedule for the following periods:

- (a) on and from the date of this direction until the Deputy Prime Minister departs from Solomon Islands on 23 September 2022; and
- (b) on and from the entry of the Deputy Prime Minister into Solomon Islands on 30 September 2022 until the Prime Minister resumes his duties on 10 October 2022.

**DIRECTION AUTHORISING MINISTER FOR MINES, ENERGY  
AND RURAL ELECTRIFICATION TO PERFORM FUNCTIONS  
OF PRIME MINISTER**

IN exercise of the powers conferred by section 38(1) of the Constitution, and acting in accordance with the advice of the Prime Minister, I, HON. PATTESON OTI, Acting Governor-General, by this direction:

- (a) authorise the person holding the office of Minister for Mines, Energy and Rural Electrification to perform the functions conferred on the Prime Minister by the Constitution (other than the functions conferred by section 38) during the period when both the Prime Minister and the Deputy Prime Minister are unable to do so commencing on the departure from Solomon Islands of the Deputy Prime Minister on 23 September 2022 until the entry of the Deputy Prime Minister into Solomon Islands on 30 September 2022; and
- (b) direct that, on the entry of the Deputy Prime Minister into Solomon Islands on 30 September 2022, the authorisation of the Minister for Mines, Energy and Rural Electrification under paragraph (a) is revoked.
