CONSUMPTION TAX ACT 2003

(Section 5(3) (a))

ORDER

IN EXERCISE of the powers conferred by section 5(3) (a) of the Consumption Tax Act 2003, the Minister of Revenue and Customs, with the approval of Cabinet makes the following Order:
