**WRIT OF ELECTION FOR A REPRESENTATIVE OF THE PEOPLE FOR THE
ELECTORAL CONSTITUENCY OF TONGATAPU 6**

(SECTION 6)

To the Electoral Commission:

WHEREAS the 2021 General Election for a Representative of the People for the Electoral Constituency of Tongatapu 6 resulted in the election of Poasi Mataele Tei.

AND WHEREAS the seat of the Representative of the People for the Electoral Constituency of Tongatapu 6 has become vacant under section 6 of the Legislative Assembly Act (Cap.4), due to the unseating of Poasi Mataele Tei on 10 August 2022 by the Legislative Assembly from his seat in the Legislative Assembly pursuant to the requirements of the Electoral Act, based on the rulings in election petition number CV76/2021 between Fane Fituafe and Poasi Mataele Tei and the appeal decision in AC11/2022 between Poasi Mataele Tei and Fane Fituafe, and the court certification from the Supreme Court dated 13 May 2022 thereby declaring void the election of Poasi Mataele Tei as the Representative for the People for the Electoral Constituency of Tongatapu 6.

NOW THEREFORE in exercise of the powers vested in me by section 6 of the Legislative Assembly Act (Cap.4), I command that you do cause an election to be held according to the law, to elect a successor to sit and vote in the Legislative Assembly as the Representative of the People for the Electoral Constituency of Tongatapu 6 and that you make return to me of the name of such member when so elected.

TO Mr. Pita VUKI, Returning Officer for the Electoral Constituency of Tongatapu 6:

WHEREAS pursuant to section 6 of the Legislative Assembly Act (Cap. 4), Lord Fakafanua, Speaker of the Legislative Assembly on the 11th day of August 2022 issued a Writ for the election of one member to sit and vote in the Legislative Assembly as a Representative of the People for the Electoral Constituency of Tongatapu 6:

NOW THEREFORE in the exercise of the power vested in the Electoral Commission *inter alia* by Section 6 of the Legislative Assembly Act (Cap. 4), and after consultation by the Electoral Commission with the Speaker of the Legislative Assembly:
