THE PORTS (DUES, FEES AND CHARGES) (AMENDMENT)
ORDER No. 10 OF 1990

An Order to amend the Ports (Dues, Fees and Charges) Order No. 59 of 1987.

IN EXERCISE of the powers conferred by sections 5, 18, 31, 32 and 33 of the Ports Act [Cap. 26], I, EDWARD N NATAPEI, Minister of Public Works, Communications, Transport, Civil Aviation and Tourism, make the following Order :-

AMENDMENT OF PARAGRAPH 1 OF ORDER No. 59 OF 1987

1. Paragraph 1 of the Ports (Dues, Fees and Charges) Order No. 59 of 1987 (the principal Order) is amended -

- (a) in subparagraph (1) by deleting the figure "18" and substituting the figure "20";
- (b) in subparagraph (2) by deleting
 - (i) the figure "5,760" and substituting the figure "6,300";
 - (ii) the figure "80" and substituting the figure "90".

AMENDMENT OF PARAGRAPH 2

2. Paragraph 2 of the principal Order is amended -

- (a) in subparagraph (1) by repealing the figures and words specified in the columns headed "Vila" and "Luganville" and substituting the following figures and words:-

"35,211 Vatu	21,127 Vatu
43,661 Vatu	28,169 Vatu
52,122 Vatu	30,986 Vatu
60,563 Vatu	33,803 Vatu
77,465 Vatu	46,478 Vatu.";

- (b) by inserting after subparagraph (1) the following subparagraph:-

"(1a) Any vessel under 60 metres in length which upon the request of its captain or the agent of such vessel uses the services of a pilot shall incur pilotage fee at the following rates:-

- (a) Vila 485 Vatu per metre in length;
- (b) Luganville 290 Vatu per metre in length.";

- (c) in subparagraph (2) by repealing the words "subparagraph (1)" and substituting the words "subparagraphs (1) and (1a)"
- (d) in subparagraph (3) by repealing the words "subparagraph (1)" where occurring and substituting the words "subparagraphs (1) and (1a)".

AMENDMENT OF PARAGRAPH 3

- 3. Paragraph 3 of the principal Order is amended in subparagraph (2) by deleting the figure "1,921" and substituting the figure "2,113".

AMENDMENT OF PARAGRAPH 5

- 4. Paragraph 5 the principal Order is amended by deleting the figure "7,682" and substituting the figure "8,450".

AMENDMENT OF PARAGRAPH 8

- 5. Paragraph 8 of the principal Order is amended in subparagraph (2) by deleting the figure "6,420" and substituting the figure "7,062".

AMENDMENT OF PARAGRAPH 9

- 6. Paragraph 9 of the principal Order is amended in subparagraph (1) by deleting the figure "5,762" and substituting the figure "6,338".

AMENDMENT OF PARAGRAPH 10

- 7. Paragraph 10 of the principal Order is amended in subparagraph (1)
 - (a) by deleting the figure "243" and substituting the figure "267";
 - (b) by deleting the figure "8.730" and substituting the figure "10,563".

AMENDMENT OF PARAGRAPH 11

- 8. Paragraph 11 of the principal Order is amended -
 - (a) in subparagraph (1) by deleting the figures "100" and "1,000" and substituting the figures "110" and "1,100" respectively;
 - (b) in subparagraph (2) by deleting the figures "50" and "500" and substituting the figures "55" and "550" respectively.

AMENDMENT OF PARAGRAPH 12

- 9. Paragraph 12 of the principal Order is amended -
 - (a) in subparagraph (1) by repealing the figures and words in the Column headed "Rate" and substituting the following figures and words :-

" 4,225 Vatu;
7,042 Vatu;
9,155 Vatu;
11,971 Vatu;
14,084 Vatu;
14,788 Vatu."

- (b) in subparagraph (3) by deleting the figure "5,762" and substituting the figure "6,338".

AMENDMENT OF PARAGRAPH 13

10. Paragraph 13 of the principal Order is amended -

- (a) in subparagraph (1)(a) by deleting the figure "326" and substituting the figure "359";
- (b) in subparagraph (1)(b) by deleting the figure "163" and substituting the figure "179";
- (c) in subparagraph (2) by deleting the figure "163" and substituting the figure "179".

AMENDMENT OF PARAGRAPH 14


11. Paragraph 14 of the principal Order is amended -

- (a) in subparagraph (1)(b) by deleting the figure "300" and substituting the figure "330";
- (b) in subparagraph (1)(c) by deleting the figure "700" and substituting the figure "770";
- (c) in subparagraph (1)(d) by deleting the figure "1.300" and substituting the figure "1,430";
- (d) in subparagraph (3) by deleting the figure "1.300" and substituting the figure "1,430".

COMMENCEMENT

12. This Order shall come into force on the 1st day of June, 1990.
