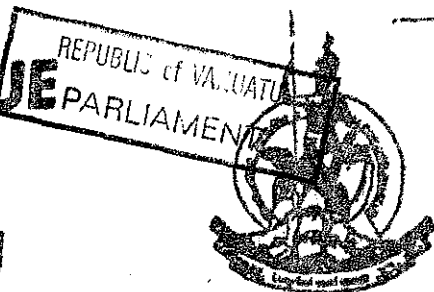

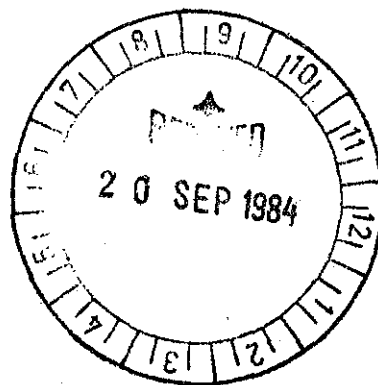

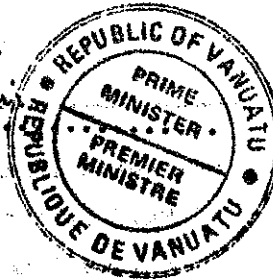

To increase the amount of Head Tax.

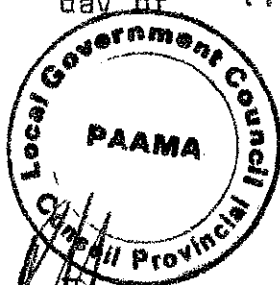
IN EXERCISE of the power contained in Section 26 of the Decentralisation Act No. 11 of 1980, the Local Government Council hereby makes the following Regional Law:

- (a) In paragraph (a) by deleting the figure "500" and substituting therefor the figure "800",
- (b) In paragraph (b) by deleting the figure "300" and substituting therefor the figure "350".

Commencement: 2. This Regional Law shall come into force on the date of its publication in the Gazette.




