**AMENDMENT**

1. The Legal Practitioners Regulation (Disciplinary Committee) Order No. 34 of 1987 as amended by Order 53 of 1987 is further amended -

In Section 2 thereof by deleting the words

"Thirty-First Day of December Nineteen Hundred And Eighty-Seven" and substituting therefor the following words "Thirty-First Day of January Nineteen Hundred And Eighty-Eight".

**COMMENCEMENT**


