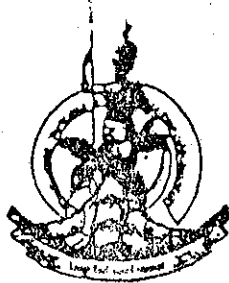

INTRODUCTION OF 100 VATU COIN

---

Pursuant to Section 19 of the Central Bank of Vanuatu Act No. 3 of 1980, the Central Bank wishes to inform the members of the public that, with effect from the date of publication of this notification, a 100 vatu coin whose composition, weight and design have been approved by the Minister of Finance will be introduced as legal tender and put into circulation as of that date.

The main characteristics of the 100 Vatu coin are as follows:

Alloy: Nickel Brass  
Colour: Yellow (metal)  
Weight: 9.5 Grammes  
Diameter: 23.5 mm  
Shape: Round  
Edge: Milled  
Tolerance: +/- 1%  
Obverse: Vanuatu Coat of Arms  
Reverse: Three sprouting seed coconuts

It is to be noted that the 100 Vatu note will continue to be a legal tender and will circulate side-by-side with the 100 Vatu coin.

INTRODUCTION OF 5000 VATU NOTE

---

Pursuant to Section 19 of the Central Bank of Vanuatu Act No. 3 of 1980, the Central Bank wishes to inform the members of the public that, with effect from the date of publication of this notification, a 5000 vatu note whose composition and design have been approved by the Minister of Finance will be introduced as legal tender and put into circulation as of that date.

The main characteristics of the 5000 Vatu note are as follows:

- Size: 160 by 78 mm
- Predominant Colour: Sepia
- Obverse: Vanuatu Coat of Arms
- Reverse: Bottom Left Hand Corner: A cruise ship at mooring  
Centre: Pentecost Land Dive  
Bottom Right Hand Corner: Cattle and coconut palms
- Serial Numbers: Located on the obverse side: at the top right hand corner as well as at the bottom left hand corner.
- Security Features: --Security thread  
--watermark
- Signatures: -President (of the Central Bank Board), and  
Minister of Finance.
