MICHAEL PATRICK PURCELL

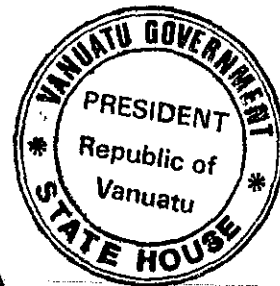
as the Public Solicitor for the Republic of Vanuatu for a period of two years. This appointment shall be deemed to have come into force on the 25th day of March, 1991.

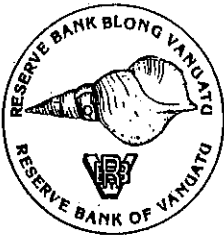

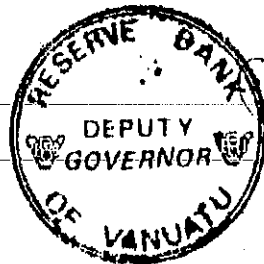

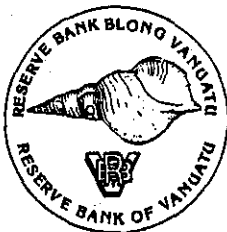
