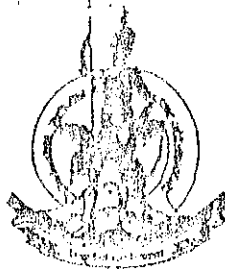

PUBLIC NOTICE

The Honorable Maxime Carlot Korman, Prime Minister of the Republic of Vanuatu, wishes to announce the following changes to his cabinet and certain Ministries including the names of those Ministers and Ministries affected, including the portfolios and responsibilities which he has assigned to each of those Ministers in accordance with Article 42 of the Constitution.

MINISTERIAL PORTFOLIOS AND RESPONSABILITIES

1- PRIME MINISTER

The Ministry of Foreign Affairs, Immigration and External Trade is hereby abolished. In lieu thereof a new department of Foreign Affairs is created and is assigned to the Prime Minister's Office, who together with his present portfolios will take over responsibility for Foreign Affairs, with particular responsibility for:

- 01 Immigration
- 02 All matters related to Foreign Countries and Organisations
- 03 Relations with International Institutions
- 04 Overseas Missions
- 05 Protocol and Resident Diplomatic Missions
- 06 Foreign Aid Policy and Aid Liaison

2 - MINISTER FOR JUSTICE, CULTURE AND WOMEN'S AFFAIRS
AND DEPUTY PRIME MINISTER

THE HONORABLE SETHY JOHN REGENVANU

Generally responsible for matters related to Justice, Culture and Women's Affairs. Will be added to his responsibilities:

Allocation of Ministerial and Official Vehicles

3- MINISTER FOR HOME AFFAIRS AND FOR DECENTRALISATION
THE HONORABLE CHARLIE NAKO

Generally responsible for matters relating to Home and Internal Affairs, Youth and Sports of Vanuatu. Will be added to his responsibilities:

Decentralisation in Vanuatu
