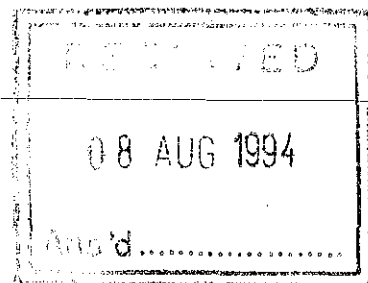

ORDER NO. 21 OF 1994

An Order to amend the Registration of Civil Status (Fees) Order No. 50 of 1987.

IN EXERCISE of the powers conferred by section 40 of the Joint Registration of Civil Status Regulation No. 17 of 1970, as amended, I hereby make the following Order:-

FEES

1. The fees payable in respect of -

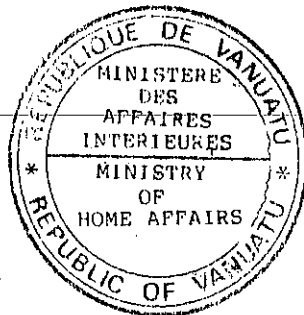
- (a) the issue of copies; and
- (b) the issue of extracts

of entries in Civil Status registers of matters set out under Column I in the Schedule shall be at the rates specified against such matters under Column II of the Schedule.

COMMENCEMENT

2. This Order shall come into force on the day of its publication in the Gazette.
