WHEREAS by section 1(1) of the Commissions of Inquiry Act [CAP. 85] it is provided that the Minister responsible for Justice may whenever he considers it desirable issue a Commission appointing one or more commissioners authorising them to inquire into any matter which on inquiry would in the opinion of the Minister be for the public welfare;

NOW THEREFORE by this Commission I appoint you the said HEATHER LEO AND JACK I. KILU to inquire generally into the following matters listed in the terms of reference

The terms of reference of the Commission of Inquiry are -

1. To enquire into the Speaker of Parliament's conduct in relation to the calling of the first extraordinary session of Parliament in 1996 and in particular,
 - a) Into the Speaker's interest in the vote of Non-Confidence Motion.
 - b) His intention of being Prime Minister should the Motion be carried.
 - c) His part in the preparation or birth of the Motion.
 - d) His involvement in the "Malaysia and Singapore" issue.
2.
 - a) To enquire into the allegations enunciated in the Report by Judge Kent concerning Chief Justice and the lack of independence demonstrated by the Chief Justice upon the Judiciary.
 - b) His high salaries.
 - c) His appearing in the Magistrate's Court before Magistrate Naviti to represent 3 defendants in a criminal case whilst on tour in the Banks with the then Prime Minister and Deputy Prime Minister.

3. To enquire into the Honourable Leader of the Opposition and Honourable Amos Andeng, MP for Ambrym Constituency for their part in the preparation or Birth of the Motion of Non Confidence.

The inquiry shall be held in public at such time or times and on such day or days as the Commissioners may determine.

The Commissioners shall be assisted by one assessor but the Minister may appoint other assessors to assist in specific cases.

The Commissioners shall make a report of the proceedings and of the result of their inquiry to the Deputy Prime Minister and Minister of Justice, Culture and Women's Affairs as soon as may be after the termination of the proceedings of the inquiry..

An order to prescribe the powers, functions and duties of a magistrate in respect of matters before an Island Court concerning disputes as to ownership of land.

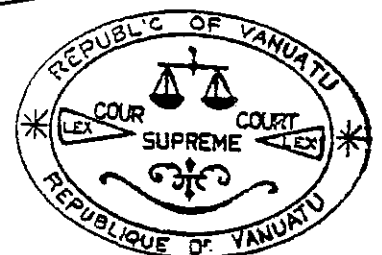
IN EXERCISE of the powers conferred by section 2A(1) of the Island Courts Act No. 10 of 1983 (as amended), CAP 167, I CHARLES VAUDIN d'IMECOURT, Chief Justice of the Republic of Vanuatu, **HEREBY** make the following order:-

NOMINATION OF MAGISTRATE TO PRESIDE IN LAND MATTERS

1. (1) Magistrate Mr Regget Marum is hereby nominated to preside over Island Courts on all land matters arising in all areas and districts of Vanuatu.
2. (2) Furthermore, he shall perform his powers, functions and duties, pursuant to the Island Courts (Powers of Magistrates) Order No. 1 of 1990, as published in the Official Gazette No. 1 of 1990.
