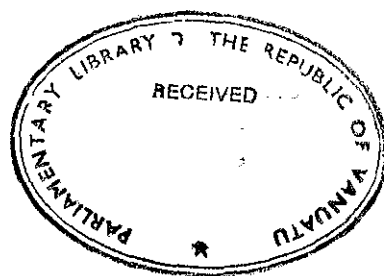

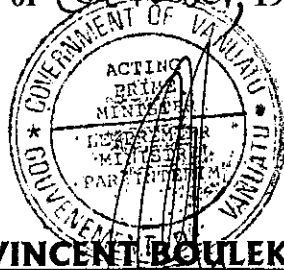
APPLICATION FORM FOR COMPENSATION

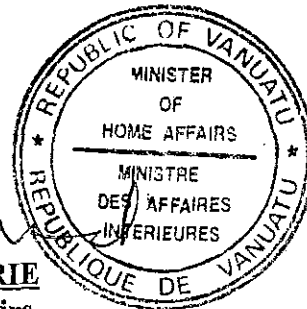

CONSTITUTIONAL INSTRUMENT

REVOCATION OF APPOINTMENT AS
DEPUTY PRIME MINISTER

WHEREAS the Prime Minister, by virtue of Article 42(1) of the Constitution is vested with the power to appoint Ministers and may designate one of them as the Deputy Prime Minister; and

WHEREAS the Prime Minister has designated the HONOURABLE BARAK T. SOPE as the Deputy Prime Minister; and

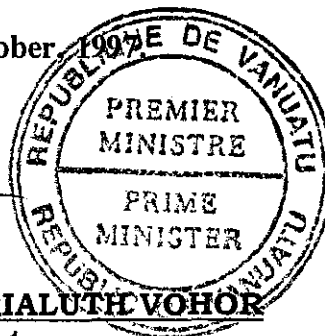
WHEREAS by virtue of these same Constitutional powers, the Prime Minister may revoke such designation,

NOW THEREFORE in accordance with Article 42(1) of the Constitution, I, HONOURABLE RIALUTH SERGE VOHOR, Prime Minister of the Republic of Vanuatu do hereby revoke the appointment of the HONOURABLE BARAK T. SOPE as the Deputy Prime Minister.

This revocation specifically relates only to his appointment as the Deputy Prime Minister.

This instrument shall be effective on the date of signature.

CITIZENSHIP ACT [CAP. 112]

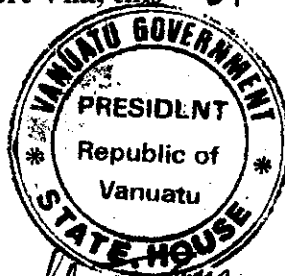

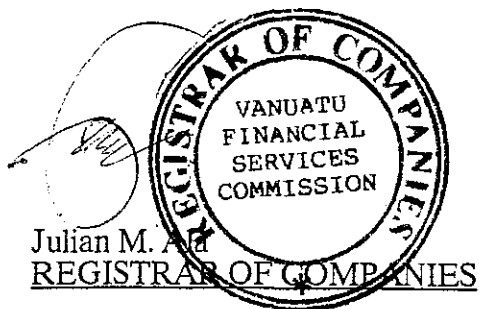
