
#### QUALIFICATION FOR REGISTRATION AS VOTER


- (1) A person will have attained 18 years on or before the qualifying date, shall be the 1<sup>st</sup> day of July on the Publishment of the Electoral roll.
- (2) For the Purpose of Electoral Registration, the Registration Officer shall register the eligible voters each year during four months of 2001 beginning 1<sup>st</sup> February to 31<sup>st</sup> May 2001.
- (3) For the Purpose for the registration in the Port Vila Constituency, the Electoral registration will begin Monday 16<sup>th</sup> April 2001.


