LAND REFORM ACT CAP 123

Declaration of land ceasing to be public land Order No. 20 of 2002

To provide for certain land to cease to be public land

In exercise of the powers contained in subsection 9(2) of the Land Reform Act [CAP 123] and in accordance with the advice of the Council of Ministers, I, the Honourable Jackleen R Titek, Minister of Lands, Geology, Mines and Water Resources, make the following declaration.


1 Certain land ceases to be public land

- (1) The land demarcated and shaded on the attached Plan 1, being land comprised within coastal strips on the island of Aore and land on the south coast of the island of Santo fronting the Belmol leasehold property, ceases to be public land.
- (2) The land demarcated and shaded on the attached Plan 2, being land comprised within what is known as old Title Number 593 situated at Rentapau on the east of the island of Efate, ceases to be public land.

2 Commencement

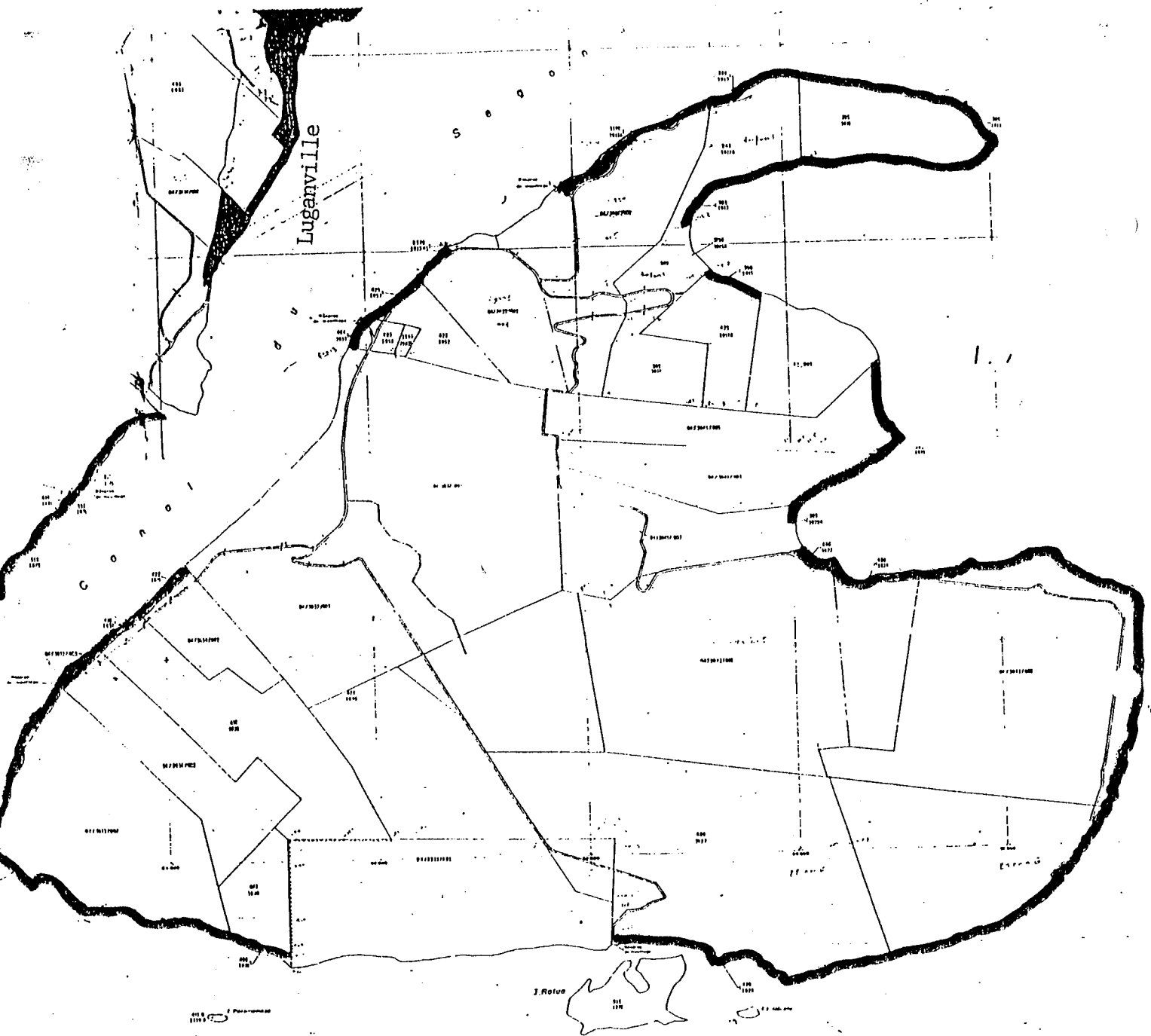
This declaration comes into force on the day on which it is published in the Gazette.
