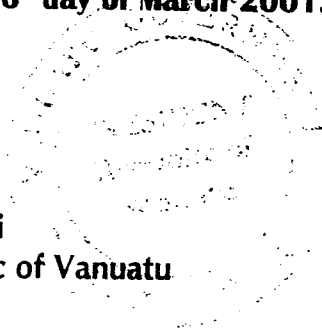

1. Appointment of the Acting Commissioner of Police

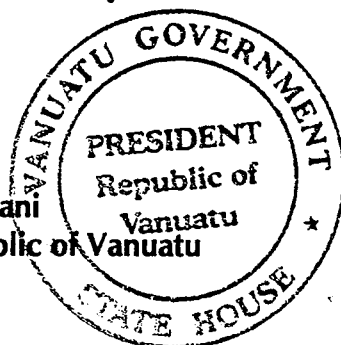
- (1) Deputy Commissioner of Police (Operations), Holi Simon is appointed to act as the Commissioner of Police.
