

**1 Remuneration, benefits and allowances**



**THE RESERVE BANK ACT CAP.125**

**TAKE NOTICE** that, with the approval of the Minister of Finance and Economic Management pursuant to section 34 of the Reserve Bank Act, the Reserve Bank hereby gives notice that:

1. Deposit rates on all whole sale funds shall not exceed 8% for all borrowing durations.
2. 8% shall be the ceiling for all whole sale deposit rates and may only be varied by the Minister upon the advice of the Reserve Bank.
3. This notice will be effected as of the date of the gazette.




