Official Gazette Fees

As of 1st February 2010, the following fees apply for subscription to the Vanuatu Government Official Gazette and for copies of documents provided by the State Law Office.

1 Official Gazette annual subscription fees

- (1) The annual subscription fee for electronic copies of the Official Gazette is VT 28, 150 (VAT inclusive).
- (2) The annual subscription fee for hard copies of the Official Gazette is VT 35, 000 (VAT inclusive).
- (3) The annual subscription fee for both hard and electronic copies of the Official Gazette is VT 63, 125 (VAT Inclusive).

2 Charge for a copy of any electronic document

The fee for a copy of any electronic document is VT 500 plus VAT.

3 Rates for copies of documents banded

- (1) The rates for copies of documents banded are:
 - (a) Band A (1 to 5 pages) VT 500 + VAT;
 - (b) Band B (6 to 9 pages) VT 800 + VAT;
 - (c) Band C (10 to 25 pages) VT 1,400 + VAT;

(d) Band D (26 to 49 pages) VT 2,200 + VAT;

(e) Band E (50 to 75 pages) VT 3,200 + VAT.

(2) In addition to paragraph (1) (e), for any document with more than 75 pages, a charge of VT 500 per block of 10 pages applies.



4 Laws of the Republic of Vanuatu (Consolidated edition 2006)

The charge for witnessing the signing of a document is VT 2000 per document (VAT inclusive).

The certification of all academic transcripts, certificates and IDs for students is free.
