In exercise of the powers conferred on me by subsection 36(1) of the Foreign Services Act No. 20 of 2013, I, the Honourable MELTEK SATO KILMAN LIVTUVANU, Minister of Foreign Affairs, International Cooperation and External Trade, after consultation with the Director General, make the following Order.

#### 1 Terms and Conditions of Employment

The terms and conditions of employment of KALFAU GEORGE KALORIS as High Commissioner of the Republic of Vanuatu to Australia and Ambassador Extraordinary and Plenipotentiary of the Republic of Vanuatu to Timor-Leste and to the United Arab Emirates are set out in the Schedule.

#### 2 Commencement

# SCHEDULE

## TERMS AND CONDITIONS

#### 1 Interpretation

For the purposes of providing for the terms and conditions of employment of Kalfau George Kaloris as the High Commissioner of the Republic of Vanuatu to Australia and as the Ambassador Extraordinary and Plenipotentiary of the Republic of Vanuatu to Timor-Leste and the United Arab Emirates:

Employer means the Government of the Republic of Vanuatu;

Employee means Mr. Kalfau George Kaloris.

#### 2 Duties of Employee

The Employee has the following duties:

- (a) to manage and direct the Mission, its resources and activities; and
- (b) to maintain friendly relations and to represent Vanuatu's national interest with Australia, and countries resident in Canberra with concurrent accreditation to Vanuatu; and
- (c) to coordinate the official activities of the various Departments and Agencies of the Government of the Republic of Vanuatu (including promotion of investment, trade and tourism); and
- (d) to advance the interests of the Government of the Republic of Vanuatu with Australia and with other countries represented in Australia; and
- to provide quarterly written reports as well as an annual report to the Minister and the Director General of the Ministry of Foreign Affairs, International Cooperation and External Trade (hereinafter called "The Ministry"); and
- (f) to carry out quarterly Mission's staff performance appraisal and send it to the Minister and Director General of the Ministry; and

- (g) to collaborate with the Department of Foreign Affairs and International Cooperation (hereinafter called "The Department") on the Head of Mission's performance appraisal quarterly; and
- (h) to carry out such other legal duties in line with this appointment as may be assigned by the Minister or the Director General of the Ministry from time to time.

#### 3 Official duties to have priority

The Employee:

- must devote the whole of his time to his employment on matters that directly concerns the Employer; and
- (b) must not engage himself or act as an employee, agent or principal of any person, corporate body or any organization on any lawful activities or dealings in the capacity as the High Commissioner of the Republic of Vanuatu to Australia or as the Ambassador Extraordinary and Plenipotentiary of the Republic of Vanuatu to Timor-Leste and the United Arab Emirates during his period of employment; and
- (c) must use his best endeavours and take all such proper steps or precautions as may be required, appropriate or necessary to prevent the loss, destruction, damage or waste of any deeds, writing, papers, books, monies, assets or other property of the Mission; and
- (d) must at all times comply with the requirements of this Agreement and all relevant Acts of the Republic of Vanuatu.

#### 4 Confidentiality

The Employee must not at any time whether during his employment or at any time thereafter (except so far as is necessary and proper in the ordinary course of this employment), make public or disclose to any person any information if:

- (a) the information relates to any dealing or matter relating to national security or protected under legislation; and
- (b) the information came to his knowledge in the course of his employment by the Employer as High Commissioner or Ambassador.

#### 5 Remuneration, allowances and benefits

- (1) The remuneration of the Employee is a monthly salary of USD 5,000.00.
- (2) The Employee is entitled to the following allowances and benefits:
  - use subject to budget, of one official car for official duties and incidental thereto serviced and maintained at Government Expenses; and
  - (b) a Transport Allowance of USD 400.00 per month will apply in circumstances where there is no vehicle owned by the Mission; and
  - (c) domestic (within jurisdiction) duty travel allowance of USD 100.00 per day for the first 7 days. After first 7 days, the domestic travel allowance will be reduced by 50%; and
  - (d) domestic (within jurisdiction) in-service training allowance of USD 90.00 per day commencing from date of workshop or training begins and ends when workshop ends. This is only applicable if the training is approved by the Employer; and
  - (e) education allowance of USD 500.00 per child per school term. The education allowance is only applicable to children under the age of 18;
  - (f) a housing allowance of USD 4,000.00 per month; and
  - (g) Medical Insurance of USD 3,000.00 per annum. The medical allowance will only be paid through refund of receipts by medical practitioners; and
  - (h) the payment of most economical route return ticket between Port Vila and the Mission once per year. In the event where the employee returns to Port Vila for an unofficial commitment, he shall be held responsible for the payment of his return ticket to his place of duty; and
  - (i) overseas mission travel allowances that are claimable upon endorsement by the Employer; and
  - (j) currency exchange rate loss for a provision of USD 600.00; and

- spouse support allowance USD 250.00 per month that is payable (k) only to a legal spouse or partner and will be paid only if a spouse accompanies his or her working partner in the Mission (based overseas); and
- a child allowance of USD 150.00 per child per month if the child is (1)under 18 years. The child allowance is only applicable for 2 children.

#### Annual Leave and sick leave 6

- (1)The Employee is entitled to take annual leave upon approval by the Employer, and such leave is to be calculated at the rate of one and threequarter working days for every month of service.
- The Employee is entitled to take sick leave at the rate of 21 days per 12 (2)months of service.
- (3)If in any period of 12 months the Employee takes a sick leave exceeding 21 days, such number of days taken in excess of the 21 days must be taken as leave without pay.

#### 7 Use of the Mission's vehicle

The Employee may use a vehicle belonging to the Mission for official purposes only.

#### 8 Termination and resignation from office

- (1)The Minister may in writing recall the Employee if he:
  - ceases to be a citizen of Vanuatu; or (a)
  - (b) becomes bankrupt inside or outside Vanuatu; or
  - is convicted of an offence inside or outside Vanuatu that is listed (c) under subsection 27(2) of the Leadership Code Act [CAP 240]; or
  - (d) is convicted for offences other than those under subsection 27(2) of the Leadership Code Act [CAP 240]; or
  - is incapacitated by an illness; or (e)
  - is not complying with his or her performance agreement with the (f) Employer; or

- (g) is regularly absent from functions without providing reasonable excuse to the Employer; or
- (h) commits the State to a bilateral agreement without authorization from the Employer; or
- consistently travels for unofficial purposes without obtaining prior approval from the Employer; or
- discloses information to the media without obtaining authorization from the Employer; or
- (k) breaches the Public Finance and Economic Management Act [CAP 244]; or
- (1) has acted contrary to a lawful instruction given by the Employer; or
- (m) brings into disrepute the integrity and reputation of Vanuatu; or
- (n) acts contrary to the Government's foreign policy.
- (2) The Employee may resign at any time by giving 3 months notice in writing to the Minister.

### 9 Surrender of government property

Upon termination of this Agreement, the Employee is to deliver to the Employer (whether or not demanded therefore is given by the Employer), all stores, articles, property, files, motor vehicle or other assets and any other materials as well as to vacate any premises occupied by the Employee by reason of his appointment hereunder to the Government.

# Penalty Notice Regulation Order No. 6 of 2015

In exercise of the powers conferred on me by subsection 20A(6) of the Animal Importation and Quarantine Act [CAP 201], I, the Honourable DAVID TOSUL, Minister of Agriculture, Livestock, Forestry, Fisheries and Biosecurity, make the following Order.

#### 1 Interpretation

Act means the Animal Importation and Quarantine Act [CAP 201].

#### 2 Penalty notice

For the purposes of subsection 20A(6) of the Act, the prescribed amount in respect of an offence committed under a provision of the Act is set out in the Penalty Notice Table as provided in the Schedule.

#### 3 Period to pay penalty

If a person served does not wish to have the matter determined by a Court, he or she must pay, within 14 days after receiving or being served with the Penalty Notice, to a person the amount of penalty prescribed under this Regulation and stated in the notice.
