#### Instrument of Appointment of Minister Order No. 164 of 2015

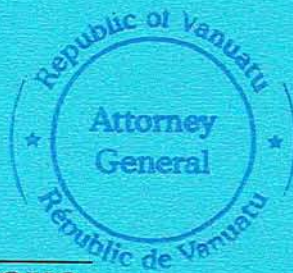
